Accounting Standards Discussion

ASC 842 status


- Adoption of lease standard change ASC 842 delayed another year to FY2022-23 by FASB, due to COVID
- RPS will prepare in FY2021/22, with longer period available for analysis and execution
- RPS will also engage with CLA in FY22 to review process and impact
- Leasequery software and data set up continues in support of standard preparation

DC current lease treatment

- Summary of Issue:
 - Real estate development structure has initial higher cost escalating long term lease with Developer leading to high levels of accrued lease liability
 - Post Launchpad buyout of Developer and bond issuance lower cost flat rate long term lease, full termination of prior lease and no continuing Developer ownership or involvement
 - RISE and RLP accrued liabilities currently at \$4.4M contributing to region negative Net Asset position of (-2.8M); Request is that liability should be extinguished as obilgation is terminated;
- Discussions continue with Aronson on current treatment of RISE and now RLP Legacy leases
- CLA engaged to provide updated support for opinions


